- This phenomenologically guided dissertation explored the lived experiences of Latinas in their interactions with Chicago Police Department, revealing a reality shaped by intersecting systems of oppression. Through the frameworks of Critical Race Theory (CRT) and Intersectional Feminism, this study illuminated how race, gender, power, and oppression converged to produce conditions of invisibility, hyper-surveillance, marginalization, and institutional neglect. Latinas' experiences of visibility and invisibility resulted in feelings of both disempowerment and disenfranchisement, which is seemingly reflected in the absence of Latinas in the literature.
